Undergraduate



For undergraduates from Germany, there are significant changes with regards to both cost and funding opportunities. The course fees have more than doubled for most undergraduate degrees from 2021 onwards. At the same time, the majority of EU students do not qualify for student loans from the British government. Unfortunately the German state also does not provide funding opportunities for an entire undergraduate degree but only for shorter time periods. UNITED KINGDOM

The United Kingdom has decided that from fall 2021 onwards, all new undergraduate students from the EU without pre-settled or settled status will not qualify for student finance in England. This means that no student loan can be provided by the British government. In addition, all of the aforementioned students need to hold a student visa to study in the UK.

GERMANY

Students from Germany still have the opportunity to apply for funding via Auslandsbafög, the DAAD, or to take a loan from the KfW Bank. However, all these possibilities are limited to a year or less. Hence, the funding is not adequate for financing an entire undergraduate degree. To the best of our knowledge, there is no such funding available at this point in time.

UNIVERSITY OF OXFORD

Starting from fall 2021, the University of Oxford charges all new undergraduates from the EU overseas fees. These vary from degree to degree, but are significantly higher than home fees. In addition, students are not eligible for the Oxford bursary any longer. As an exception, all EU students with pre-settled status or settled status qualify both for home fees and for the Oxford bursary. Details can be found on the official University webpages below.

ERASMUS+

The UK is no longer an EU Member State. It has also opted not to take part as an associated third country in the new Erasmus+ programme 2021-27. However, all projects selected under the Erasmus+ programme 2014-2020 will continue operations until their completion on the same basis under which they were selected. This means that a number of existing projects and partnerships will continue on the basis of these 2014-2020 rules.
